- perform hearing tests for children;
- communicate with patients with hearing loss and their relatives;
- assess the needs of patients with hearing problems and consider the selection of the appropriate hearing device;
- perform his or her work in accordance with the legal background and professional guidelines for the provision of hearing devices;
- actively participate in the provision of hearing devices;
- use an otoscope, interpret what can be seen, recognise factors which may influence the taking of impressions;
- chose the appropriate earmould in cooperation with the doctor, take impression for the earmould;
- adjust hearing devices;
- teach the use of hearing devices;
- participate in the care of patients with hearing devices.
