- Fulfil data supply and registration obligations;
- Take the necessary records and write business letters;
- Open, close and operate the store/site/showroom/ suiting prescriptions relating to security and property protection;
- Welcome customers;
- Observe the most important prescriptions relating to goods and property protection within the checkout operator's job;
- Take over and handle money, cash replacement money orders, meal tickets, arrange payment by card and issue invoices on the purchases as required;
- Hand over the amount due back to the customers and the receipt/invoice in accordance with the rules;
- Settle accounts at the end of the shift;
- Operate individual machine types skilfully;
- Check the condition, operation of the machine, replace the ink toner and ribbons, if necessary;
- Make out the bill and perform possible repairs;
- Handle other machines and equipment at the checkout operator's work station (bank card reader, barcode reader, electronic scales);
- Participate in taking inventories;
- Hand over goods to customers, wrap up goods depending on the profile and nature of goods.
