- Reconstruct cadavers and take samples;
- Participate in obtaining transplant tissue;
- Take samples for histological examinations;
- Pack the box containing samples for detecting poison;
- Take a sample of material for diatoma examination;
- Preserve exhibits of a criminal act;
- Prepare and store specimens;
- Obtain anthropological material;
- Obtain material for DNA tests;
- Apply criteria pertaining to the removal of organs and tissue, and to health documentation.
