3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- Manually direct traffic, put temporary traffic-diverting instruments in place;
- Ensure visibility of traffic technology instruments;
- Recognise and repair faults in the pavement and perform repairs on curbs;
- Level public utility covers;
- Handle a demolition hammer, a hand-directed vibratory roller, a forward plate compactor and machinery not requiring a permit;
- Transport material and instruments manually;
- Manually load material and instruments into a vehicle;
- Load (road) construction material using manual tools;
- Paint road surface markers;
- Section off the work area (construction and demolition);
- Create the geometry of the base structure and freeze protection layer (even out, spread) and help work in the base structure and freeze protection layer using machinery;
- Create the geometry of special earthworks (even out, spread) and manually help work in the material of special earthworks using machinery;
- Create the geometry of road fill (even out, spread) and help work in the fill material using machinery;
- Build a pavement edge and pavement (elevated, sunken);
- Apply concrete (manually) using pre-mixed concrete, compress and post-process concrete;
- Build a water-drainage system;
- Select equipment and machinery;
- Carry out preparation work at work sites;
- Participate in the process of delivering work;
- Perform labour safety tasks;
- Perform administrative and communication tasks;
- Load leftover, waste and hazardous material and clean the work area.
