- recognise causes hindering the execution of a leakage rectification task and actively contribute to their elimination;
- report defects and breakdowns observed in the course of performing such work;
- apply Kautasit seals, Kautasit segment seals and resin surface seals;
- install, use, remove and store special tools and appliances needed for sealing in accordance with professional requirements.
