- Prepare and oversee execution of custom-tailored annual training plans;
- Take into account accident prevention aspects in the course of training sessions and competitions, give first aid if necessary;
- Promote health-oriented forms of recreational activity;
- Cooperate with other physical culture and healthcare professionals.
