A typical holder of the certificate is able to:

- assess tasks to be performed, inspect the condition of and inscriptions on the vehicle's body;
- examine and, if necessary, repair, replace the main frame, vehicle's body, side and cross-members, buffer and draw gear, internal equipment and external fittings;
- examine and, if necessary, repair, replace the main drive, reversing gear, traction control system, traction motors, power conduction components, axle drives, drive components, hydraulic drives, vigilance and Unified Vigilance and Train Control System equipment;
- check and, if necessary, repair, replace components of the system of instruments and ancillary equipment;
- examine the operation of and, if necessary, repair the diesel engine in keeping with technological instructions;
- check lubricant levels, fill up or change liquid fillings, set, repair, change the emergency reservoir;
- examine, repair, replace devices, replace (turbo, compressor) filler, fuel injector, component of the lubricant and fuel feed system and the components of the cooling system.
