- shape work pieces following basic manual and metal cutting procedures, including those applicable to small handheld devices;
- check the lubrication, measurement and protective system of machinery;
- place and fix workpieces, set parameters;
- lathe cylindrical, flat, conic and shaped surfaces, cut threads;
- perform whetting;
- carry out machine maintenance tasks;
- keep shift organisation documentation.
