- apply his/her technological skills in a creative way in the field of production with full knowledge of the structure and qualities of the leather, the history of leather currying, the basics of currying procedures and the factors influencing quality as well as the defects of the leather, apply the rules of object forming and new technological skills;
- group the products of the leather industry (classification of finished leather on the basis of types, currying and usage) with full knowledge of its fields of usage, and choose the basic material;
- prepare leather products with full knowledge of other raw materials of the leather industry such as: textile, artificial leather, metal, other artificial material, threads, auxiliary material, leather industry glue, solvents, paints and colouring agents in the leather industry, apply decoration methods (colouring, batik work, inlaid leather, pressing, cutting, stamping, punching);
- select the technical tools, raw materials and working processes necessary for the task and its purpose;
- prepare studies related to object forming tasks (collecting, forms, motif drawing, draft projects, variations, studies of the form, maquettes), produce scaled drawings, the graphic representation and the design of the object to be prepared;
- draw a correct pattern for the leather object, perform basic operations (cutting, thinning), cut according to the model, carry out gluing and sewing operations;
- use manual and machine tools and appliances necessary to perform the work expertly; -represent the harmony of form and function in the finished products;
- apply object forming methods the most suitable way.

### Further information (including the description of the national grading method):

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
