- A typical holder of the certificate is able to: - execute tasks of both top persons and bases; - toss and catch the top person while standing on the shoulders of the base in group stunts; - execute simple tumbles; - secure landing of partners from tumbles or other acrobatic elements; - participate in pyramids; - present his/her artistic skills regularly, several times a day, at the same artistic level; - present his/her performance based on his/her basic dance skills (classical ballet, modern technique) with movements that harmonise with and fit the character of the performance; - use properly and be aware of requisites that enhance the effect of the performance (such as costumes, make-up, music, lights); - join in within a short time any production that he/she is qualified for; - assess locations suitable for rehearsals or performances (size of room, quality of flooring, whether the weight-bearing capacity of attachment points is suitable for attaching instruments, etc.); - execute tasks belonging to the genre according to the given requirements; - design his/her own production with the background knowledge about the main stages of ancient and modern circus history, the history of the evolution of the Hungarian circus, his/her own field's history of evolution, the main styles of contemporary modern circus art, and the characteristics of circus life; - do his/her job with due care and make use of fundamental aids to prevent accidents; - check requisites and equipment used during his/her work regularly, with the necessary background knowledge of work safety provisions; - apply the relevant legal knowledge (labour law, copyright, contract law, basic rules of public administration).

### Further information (including the description of the national grading method):

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
