3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- supply a sculptor's studio performing stone-carving, bronze-casting, wood-carving, terracotta or plastic-working activities, and properly handle the materials used;
- safely use and maintain small machines and aids used in sculpturing (from the centre punch to the abrasive wheel type cutting-off machine);
- assess and design the professional task based on his/her knowledge of the classical genres of sculpturing, the basics of anatomy, the traditional materials used in sculpturing (terracotta, wood, stone, bronze, artificial stone and stucco), their features, possible applications and handling, the up-to-date materials of sculpturing (plastic, glues and alloys), the techniques these new materials require, the tools and machines required for processing, and duplication techniques;
- make open-air sculptures based on 2-D representation (drawing, film, photo and video recording);
- make frames and supporting structures suitable for the specific task based on his/her knowledge of their construction method;
- model, engrave, emboss and carve medals, reliefs, portraits, and human and animal figures;
- make dummy forms, piece forms, glue forms and silicon rubber forms, make positive forms from clay, gypsum and plastic;
- make building decoration elements on his/her own, make geometric ornament elements;
- make the special tools used in sculpturing (modelling board, embossing tools, gypsum chisels and plastering tools, screen frame making and chasing hammers);
- model a sculpture from clay (plastiline) copying nature in a 1:1 scale;
- prepare the sculptures for erection;
- apply the organisational methods required for sculptors (material purchase, design, work organisation, execution and assembly).

- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification, $\,$
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
