3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- play the piano with good musical expression and technique, transpose pieces, sight read and sight play scores and accompany singers and musicians;
- take down homophonic and polyphonic tunes by ear;
- take down the treble and bass of difficult classical passages and four part exercises with varied chords and figurations as well as work out the same exercises in close position marking the harmonies;
- read music in C clef and transpose into a new key (singing and playing the piano and in writing as well);
- sight-read plain tunes and independently sing parts in chamber music staying in tune, perform polyphonic pieces by singing and playing the piano:
- sing the given scales exercise and songs of her/his own repertoire with the proper breathing technique and light muscular tension, clearly, and in the appropriate style;
- analyse pieces of music, and interpret each component separately and in its context in an adequate style;
- conduct the commonest beats with the proper posture and hand position;
- teach and play two or three part songs of medium difficulty as well as simple homophonic four part songs on the piano singing one of the parts;
- conduct two or three part songs accompanied by a small group of instruments;
- play the piano in a natural way with a sensitive touch, sight play fluently piano pieces (or transcriptions) of medium difficulty, play simple accompaniments at high standard;
- play scales on the piano in keys from 7 # to 7 b, over 4 octaves with parallel and contrary motion, legato and non-legato, gradually speeding up the tempo, play common chord and seventh chord arpeggios (over 4 octaves as a passage as well), play tunes in octave parallel, chromatic scale, glissando and tremolo;
- $-\ sing\ in\ tune\ with\ clear\ diction,\ use\ her/his\ voice\ resonance\ properly\ and\ express\ feelings\ while\ following\ the\ most\ important\ signatures;$
- be familiar with the most important eras of music and art history drawing on her/his background knowledge about music and art history;
- draw parallels between the most significant events of music history and world history as she/he has a thorough background knowledge on the musical styles and their characteristic features, the typical genres and forms as well as their evolution of the different periods;
- quote selections of different musical styles by heart, recognise pieces of music learnt and analysed, their characteristic themes and excerpts, structural features and tonal peculiarities;
- be familiar with contemporary music styles.
- carry out ethno-musical studies, especially on the history of international folk music research and the folk music of other nations;
- perform Hungarian works inspired by folk music in a clear and simple way and with appropriate style, using the characteristic ornaments of Hungarian folk music:
- analyse folk songs, using the correct technical terminology, based on their scale, tonal system, form, cadences, number of syllables per line etc. and take down the draft of folk songs and simple instrumental melodies.

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
