- play and take down jazz standards applying the proper technique as she/he knows the most important works for her/his instrument;
- meet the standards for jazz musicians and play and improvise as a soloist or member of a jazz band as she/he is aware of, and has acquired, the most important elements of the practice of playing jazz and the technique of improvisation;
- have an overview of the periods of jazz styles as well as their connections to other fields of music and use her/his classical music skills creatively in playing jazz;
- reliably recognise, reproduce and memorise jazz performances due to her/his trained ear for music;
- orchestrate pieces for small combos, play in small combos, combos and big bands and adapt to partners' and band leaders' attitudes and instructions;
- play basic technical exercises (starting and finishing notes, vibrato etc.) and scales through the whole range of her/his instrument, and break down chords;
- analyse solos from notes, make transcriptions;
- play and improvise in 8 different blues types (minor and major blues, various harmonies);
- improvise over II-V-I cycles in different tempi and different keys;
- play the exercises 1-15. in the 'Jettel book' volume I. and the pieces in Viola: The Technique of the Saxophone II.;
- have and perform at least 25 well-known jazz standards on her/his repertoire (theme and chords, solo).

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
