(THIS TRANSLATION HAS NO LEGAL STATUS)**3. PROFILE OF SKILLS AND COMPETENCES****A typical holder of the certificate is able to:**

- play scales and triads, as well as third, and sixth with double stopping in a quick tempo, steadily over 4 octaves in a substantial tone, in a relatively wide dynamic range with reliable intonation and vivid rhythm, and play cantilenas in piano and forte;
- play substantial notes even in higher positions and play an expressive vibrato with each of her/his fingers;
- make smooth shifts as he/she knows fingering and positions, play steady pizzicato in moderate tempo, play agogics properly and synchronise the movements and mechanisms of her/his left and right hand in order to resolve rhythmic problems;
- widen her/his dynamic range from an intensive pianissimo, through a warm forte, up to a risoluto fortissimo sound;
- express the basic musical characters (dolce, cantabile, espressivo, risoluto) and use the associated bow strokes;
- play in a dynamically rich, expressive tone, use her/his own fingerings and play pieces accurately from notes in the appropriate style, with a sensible phrasing that reflects the logic of the given piece;
- play pieces accurately from notes in the appropriate style, with a sensible phrasing that reflects the logic of the given piece using her/his background knowledge on the history and the most important composers and performers of her/his instrument, the works composed for it and the characteristic features of the Baroque, Classicist, Romantic and contemporary music;
- create fingerings and bow strokes independently that fit the structure and style of the given piece of music as well as the structural peculiarities of her/his own hands, perform longer pieces and learn pieces independently;
- read and sight play fluently in alto clef;
- sight play reliably at a level required for playing chamber and orchestral music, play chamber music in tune with other instruments;
- read music in C clef and transpose into a new key (singing, singing and playing the piano; in writing as well);
- sight-read and independently sing parts in chamber music phrasing appropriately and staying in tune;
- sing in tune and perform part songs or polyphonic pieces singing one part and playing the rest on the piano;
- analyse pieces, and interpret each component separately and in its context with adequate style as she/he has background knowledge on the harmony, forms and styles of music;
- take down homophonic and polyphonic tunes by ear;
- sing and play pieces by heart (voice and piano);
- play the piano in an easy and natural way with a sensitive touch, sight play simple pieces (or transcriptions) fluently, play simple accompaniments at high standard and play works for the piano in an authentic style;
- play scales on the piano in keys from 7 # to 7 b, over 4 octaves with parallel and contrary motion, legato and non-legato, gradually speeding up the tempo, play common chord and seventh chord arpeggios (over 4 octaves as a passage as well), tunes in octave parallel, chromatic scale, glissando and tremolo;
- be aware of the periods of music history, place composers in the appropriate period with a tolerance not exceeding fifty years;
- recognise the structural, stylistic and sound characteristics of unknown works and recognise known works after listening to short excerpts (several times) as well as use her/his knowledge in everyday practice;
- perform Hungarian works inspired by folk music in a clear and simple way and with appropriate style, using the characteristic ornaments of Hungarian folk music;
- analyse folk songs, using the correct technical terminology, based on their scale, tonal system, form, cadences, number of syllables per line etc. and take down the draft of folk songs and simple instrumental melodies.

Further information (including the description of the national grading method):

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
