- differentiate between types and dialects of dances and analyse steps based on his/her knowledge of the history of folk dance, the regional and historical segmentation of Hungarian folk dance and the traditions of folk dance;
- perform choreographies based on the form of expression and built on authentic elements of folk dance;
- learn dances, the different types of dance and series of elements of original dances of the various regions of Hungary;
- learn Hungarian ethnic dances, dance dialects and various styles, apply the characteristic differences between the dances of other nations in his/her performance;
- perform in a dance ensemble with a partner or with the other members of the ensemble;
- coordinate music and dance, dance as a soloist or with other members of the ensemble drawing on his/her performer skills and movement style;
- perform the series of exercises of male-female dance duets aesthetically;
- perform a choreography or part of a choreography from a given set of dances and adapted folk dance themes, knowing the steps and order of dances of the specific region studied, and freely vary and perform with style part of the choreography;
- perform his/her tasks based on the instructions of his/her employer's professional manager, or perform the tasks undertaken individually, meeting the employer's expectations;
- apply the required legal knowledge (labour law, copyright, contracts, basic administrative regulations).

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,
- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,
- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
