#### 3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- check the accuracy of the structure's setting-out and verify the completion of soil mechanics, environmental and other surveys and tests;
- monitor compliance with local authority permits and regulations, deadlines, quality requirements, and contracts;
- countersign and comment entries in the site diary and other records;
- enter defects, deficiencies or deviations in the site diary;
- propose amendments to client for technical or economical reasons;
- check the quantity and quality of work prior to covering-up;
- take part in the handover-takeover procedure;
- check the indicators of technical performance of each type of structure;
- check compliance with technology-related safety regulations;
- verify the conformity and check the presence of built-in materials, structures, and equipment;
- check the heating, ventilation as well as the water supply, drainage, and gas network installation works within the structure or the boundary up to the relevant meter, of a building of common function and structure, comprising basement, ground floor and further two floors, with a span (between walls or columns) of maximum 6.6 m and a gross floor area of maximum 500 sqm.
