# 3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- advise on style and fashion independently or under the guidance of a fashion designing artist;
- help choose the most suitable models and accessories in boutiques for individual customers;
- make model drawings for individual customers or for collections using various drawing techniques as well as the technical drawing for making samples;
- design pieces of ladies' (men's, children's) clothing (blouses, skirts, waistcoats, dresses, suits, coats, knitwear, leatherwear, underwear, swimwear, sportswear, livery, uniforms, etc) for fashion shows or as parts of commercial collections, taking into consideration the most suitable materials, cut and fashion;
- design the materials to be used for the models or design models for existing materials;
- participate in the organization of exhibitions and fashion shows, in choosing the colours of collections and the garments of the individual, in matching colours and in choosing and composing colour combinations taking into consideration the wearer's personality, their age, the occasion, etc.;
- prepare the model designs of commercial collections in several colour varieties;
- participate in determining the sewing operations and in controlling the finishing process while making the models;
- participate in designing and making the profile of advertising-, photography- and model agencies, fashion magazines, stores, shops and boutiques.

#### Further information (including the description of the national grading method):

The basis of the grading system is a list of vocational and examination requirements compiled in accordance with uniform criteria and structure, issued in the form of legal regulation that includes the following:

- identification number and description of the vocational qualification as specified in OKJ and the relevant FEOR number,

- school and vocational prequalification required for the start of the training, aptitude and vocational competence requirements and prescribed practice,
- the most typical occupation or activity accessible to the holder of the vocational qualification certificate, the short job description, and the list of related vocational qualifications,
- the duration of the training required for the vocational qualification; maximum number of hours; the ratio of theoretical and practical training; the number of vocational training classes in the vocational training school; the duration of initial training period; the possibility of organising a grade examination assessing the efficiency of practical training,
- occupational requirements of vocational qualification,

- requirements pertaining to vocational examination.

The vocational and examination requirements will be classified by the occupational group committees of the National Qualification Register (OKJ) and by the National Council for Vocational Training, and subsequently they will be issued in the form of legal regulations.
