**A typical holder of the certificate is able to:**

- perform measurements, setting outs and level setting;
- compile wood formwork components;
- install and fix the traditional formwork elements and supports of vertical and horizontal structures;
- inspect formwork dimensions, setup and stability;
- make arrangements for the storage of waste and hazardous waste in compliance with the applicable rules and regulations;
- disassemble traditional formwork;
- check the stability of formwork and scaffolding structures built up from system components;
- remove nails from, treat and store timber;
- assemble and install the systems and scaffolding of pillars, walls and roofs;
- prepare the materials for system formworks of different types and structures;
- disassemble and move formwork and scaffolding systems;
- clean, maintain and store components of system formworks and scaffoldings;
- place and work concrete into monolith concrete and reinforced concrete structures using ready-mix concrete;
- count, order, store and use materials;
- build and disassemble traditional formworks and scaffoldings;
- build, disassemble and maintain system formwork;
- install insulation materials and foils at the places needed;
- use PPE equipment;
- perform general business tasks;
- perform works related to the maintenance and cleaning of the work site and tools;
- operate the machinery, equipment and instruments required for work;
- comply with safety regulations;
- comply with fire safety and work safety regulations while working;
- cut traditional formwork panels to size;
- in case of an accident, proceed according to regulations.
