- participating in air, water and ground protection duties;
- participating in waste management and wastewater management duties;
- participating in maintenance and management duties, in environmental inspections and in the handling of regulatory infraction cases;
- handling of complaints;
- participating in tender issuance and implementation projects;
- maintaining contact with environmental and conservation authorities, and with the residents on local government land;
- participating in the compliance effort with environmental and safety laws and regulations;
- participating in the development and introduction of environmentally friendly procedures in shop representative areas, and to inform employees regarding the harmful effects of the used equipment and the method of protection;
