- Use theatre, amplifying, sound recording, programme producing and fil microphone techniques tailored to the requirements of sound scenes;
- Design, plan, prepare, document and archive theatre sound technical works, concert and event amplifying work, studio, film/video work and programmes;
- Plan and prepare the amplifying, studio, programme producing, film, video and internet sound technical work based on the understanding of the operation of sound technique systems, devices and equipment;
- Install, implement and build a system of theatre, amplifying and sound recording equipment, as well as electronic musical instruments, programme producing and distributing equipment, theatre amplifying, radio/television information, directing and communication systems;
- Use computers and IT tools, special internet audio technical hardware and software, audio technical instruments, tools and systems;
- Control and monitor work flows, audio recordings, tools and systems, perform audio technical measurements;
- Supervise and control the theatre amplifying, studio, film, video, post-dubbing and internet audio technical tasks under his/her direction;
- Manage audio resources and audio media;
- Post-editing work on audio recording, editing of audio materials;
- Broadcast live audio events, produce shows and programmes, make and mix analogue and digital sound recordings;
- Amplify theatre performances, concerts and other events;
- Adapt to the environmental effects and environment protection regulations;
- Develop and program automatic audio recording, program playing and information systems;
- Familiarising with and applying new tools, systems and technologies.
