- Perform coordination activities with the supervisors of organisations and technical areas;
- Organise and supervise the work of staff performing rail freight transportation and synchronise the tasks of colleagues;
- Organise, execute and insure the tasks of freight transport falling within his/her scope of responsibility;
- Cooperate in making the freight transport activity more effective and in executing and organising the tasks;
- Apply and operate the technologies used in freight transport;
- Perform the operating, coordinating, organising and controlling tasks related to freight transport;
- Perform the activities related to the train traffic and the takeover and receiving of trains;
- Arrange the tools required for the technological processes and the availability of workforce required to perform the activity and coordinate the necessary regrouping of staff;
- Perform the freight transport tasks related to the transport contract;
- Determine, organise and check the servicing of the place of loading;
- Complying with the stipulations laid down in the national and international regulations on freight transport, implement the safe transport of goods and the provision of quality services to customers;
- Provide quality freight transport services and ensure that the revenues of the freight company are achieved by the constant liaison with clients and by organising, administering and documenting the freight services;
- Performing the organising, coordinating and operational tasks related to the preparation of trains, the operation of freight trains according to schedule and the processing of freight transport data at the station(s) under his/her charge.
