- Provide information, education, and counselling on risks associated with employees', jobseekers', students' work, options for prevention, and use of personal protective equipment;
- Participate in organising public health education programmes;
- Participate in administering protective job-related and non job-related vaccinations;
- Participate in organising first-aid and emergency medical care, and in professional training of staff first-aiders;
- Participate in primary care for accidents and other emergency medicine cases;
- Participate in employees' occupational rehabilitation;
- Perform administrative and documentation operations.
