- Recognise the subjects polluting the nature (ground, water, air and the living world) and solve the protection against them;
- Perform forest stock-taking, evaluation and land surveying work according to the recognized scientific and operative methods;
- Control and supervise the nature conservation activities forests, grasslands and reed areas, and maintain nature conservation facilities;
- Perform forestry and agricultural factory tasks, take part in agrarian and environmental management and in the implementation of land management;
- Perform the photogrammetric evaluation of information related to nature conservation, execute field alignment, levelling and use computer information systems;
- Monitor the stock of protected plants and animals;
- Carry out professional guided tours and liaison with the official organs;
- Check compliance with the instructions/directives regarding the protection of the natural and archaeological heritage within the scope of responsibility for the entire administrative are;
- Prepare and take part in the execution of nature preservation administration tasks (licencing procedures, checks, controls, visits by the authority, environmental impact assessments);
- Maintain administrative relations with the environment protection and water management authorities, the local mining and agricultural organisations and the local governments;
- Take part in the preparation of the regulation and structural plan of the settlement's environment protection program;
- Perform inspection tasks related to the protection of local natural values, landscapes and public areas;
- Perform the administrative tasks related to nature and landscape conservation;
- Observe the nature conservation and environmental regulations and directives and check the fulfilment thereof;
- Conduct stop and search operations and initiate infringement, criminal or administrative proceedings against persons endangering or threatening the property or the nature;

- Perform sustainable greenfield management and maintenance of settlements;
- Perform project planning in nature conservation projects and perform project management tasks..
