- write PLC programs, edit such programs in graphical and test-based program languages;
- use micro-controllers (PIC);
- operate mechatronic systems;
- install, configure and use electronic design software;
- implement and check the operation of electro-mechanic controls;
- implement, install and activate engine controls (engine protection, starting, reversal switches, rpm changing connections);
- manage and operate electronic controls;
- use and operate remote controls;
- perform and supervise maintenance works as per the maintenance instructions;
- document operating and maintenance works.
