3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- Identifies the presence of the most significant risk factors regarding mortality among beneficiaries, guides the individual to basic care;
 Identifies individuals and families under disadvantageous or multiple disadvantageous conditions, is capable to set up a simple
- problem-map; Identifies the different types of impairments, assists the family to access care and organizes simpler accessibility task;
- Keeps contact with families in need, cooperates in managing and resolving crisis situations due to living related problems;
- Maintains information and communication channels with his/her professional supervisors and if required, other organizations or its representative involved in the assistance process;
- Assessing the basic needs of an individual and a family and identifies problems occuring due to modification of necessities;
- Identifies crisis situations concerning the individual or the family, guides the individual or the family in crisis to the right place;
- Assists the family in taking care of the permanently ill patient;
- Assists the family in taking care of a dying person, keeps contact with the relatives and professionals;
- Assists in managing tasks related to the deceased, provides support for the relatives;
- Assists the family in satisfying the new needs of a patient with chronic disease, focuses on the mental and physical condition of the family and relatives;
- In a case of an in-patient, identifies the basic nursing and caring defectivenesses or the problems originating from the loosing of self-preservation parly or completely (lack of moving, bedsore,malnourishment, dehydratation) must immediately call for help;
- Teaches the family members and relatives to perform simpler caring actions for home-patients and to apply tools to make nursing easier;Identifies potential risk factors that may cause domestic accidents, assists the family to avert them;
- Gives first aid on an elementary basis without tools, securely calls for physician, ambulance;
- Takes part in the work of community plarforms, takes part as an organizer at community happenings and organized events.;
- Assists in implementing regular or occasional screening tests for citizens:
- Identifies public health and epidemic related risk factors in his/her environment;
- Takes part in the screening for head-louse and manginess, in the medical care of simpler cases and learns the practical know-how regarding hygienic regulations;
- Identifies diseases occuring at the population belonging to the high-risk group (tuberculosis, sexually transmitted diseases). When required, trains the family or the patient or healthy individual to maintain proper personal hygiene and to maintain his/her physical and public health environment;
 - Supports the family and the individual in quitting smoking and fight against other harmful addictions;

Performs genuine communication, exemplary behavior.
