- recognise the behaviour/state of crisis and take necessary measures;
- use the elements of communication in accordance with the mental state of the patient, thus assisting to the recovery process;
- provide mental support to the patient and relatives, perform health educating activities;
- recognise conflicts and start to solve them;
- participate in prevention, health education and prevention of self-harm behaviour;
- teach and practice techniques falling within the scope of occupational therapy, thus forming habits, and developing skills, competences and cognitive functioning;
- recognise deviant behaviour;
- satisfy the basic and higher needs of psychiatric patients in an age-appropriate manner;
- perform psychiatric care activities in an age-appropriate manner;
- participate in the recording of psychiatric tests;
- prepare the patient and participate in psychiatric diagnostic and therapeutic procedures;
- apply restrictive measures (if necessary);
- perform mental-hygienic activity;
- perform health education in an age-appropriate manner;
- form habits, and develop skills, competences and cognitive functioning.
