- Perform and evaluate ECG examinations, recognise dysrhythmia, prevent life-threatening dysrhythmia;
- Handle artery and venous cannula;
- Measure central venous pressure;
- Assemble and handle respirators and check their operation;
- Perform trachea-bronchial toilet;
- Prepare for and assist in procedures performed by the intensive care units;
- Take active part in life-saving procedure, operations;
- Prepare for and assist in diagnostic and therapeutic procedures;
- create and maintain a safe and hygienic environment;
- Take part in the training/education of nurses performing their professional practice/traineeship and in the research and development of intensive care;
- perform tasks related to quality assurance and improve processes.
