- Identifying the material used and the production method of the painting and graphic art;
- Apply simple test methods;
- Performing the identification, appraisal and pricing of paintings and graphic art;
- Identify the type, artistic features, origins, and age of the artefact;
- Identify the artefact's material, and the technique of its preparation and decoration;
- Use catalogues, sample books and other relevant resources to identify the artefact;
- Identify, appraise and price artefacts (glass, china, ornament, weapon, Oriental antique, clock, icon);
- Identify the type, artistic style, origin and age of furniture or rugs;
- Identify the material, making and ornamentation techniques of furniture and rugs;
- Perform identification, appraisal and price estimate for furniture and rugs;
- Conduct cash purchase activities;
- Engage in commercial activities and conduct auction and commission sales;
- Engage in appraisal of pawned articles;
- Be up-to-date on the latest market prices.
