- carry out on-site measurements and analytical examinations on environmental samples, assess results;
- discover sources of pollution arising from different technologies;
- participate in the preparation of environmental protection plans;
- keep contact with environmental and nature protection authorities, in municipal areas with the population;
- participate in proposal writing and implementation;
- act in the case of complaints;
- perform data provision;
- keep records on protected natural values and polluted areas;
- keep records on environmental data and emissions;
