3. PROFILE OF SKILLS AND COMPETENCES**A typical holder of the certificate is able to:**

- observe patients;
- assess patients' conditions;
- communicate with the team using the terminology of the profession;
- apply the basic techniques of Swedish massage (effleurage, petrissage, rhythmic tapping, friction, vibration) during the refreshing massage by using different vehicles (soap, talc, cream, oil);
- apply different types of massage during the massage of the body and certain body parts (such as massage under shower, hammam massage, cellulite massage, honey massage, chocolate massage, brush massage, and water jet massage);
- perform aromatherapy massage;
- perform treatments of different temperatures and dimensions (such as masks, rolling, washes, rubbing, cold-water dousing, medicated and herbal bath therapies, whirlpool baths) during balneotherapy and hydrotherapy treatments;
- perform carbon dioxide ice, carbonic acid gas, carbonated bath treatments;
- perform sudatory, steam bath and sauna treatments, perform the tasks of sauna masters (pouring water over the stones);
- perform mud treatments (prepare for different mud treatments, perform mud compress therapy, mud baths and partial mud treatments, mud massage therapy, mitigated mud therapy, Parafango therapy), perform the tasks after mud therapies;
- perform spinal traction treatment;
- perform drinking cures;
- perform first aid tasks (treat injuries, treat and prevent injuries caused by electricity or high temperature, resuscitation, recognise problems related to the blood sugar level and blood pressure);
- use equipment and vehicles (talc, cream, oil, soap) necessary for massage professionally, clean and disinfect them after treatment;
- comply with hygiene rules, with special respect to biological risks;
- Adhere to ethical norms of the trade, regard his/her profession as a vocation;
- perform administrative tasks related to his or her activities;
- use professional expressions during his or her work;
- comply with labour-protection, environmental protection, fire protection and shock prevention rules and provisions;
- comply with rules on patient rights and patient safety;
- apply therapy massage, disease-specific therapy massage, recognize diseases on the basis of the patient sheet, and treat rheumatologic, orthopedic and traumatology diseases;
- perform segment massage;
- perform connective tissue massage;
- perform periosteal massage;
- perform lymphatic drainage;
- perform passive stretching;
- keep records relevant to work;
- comply with the rules and regulations on hygiene, environmental protection and fire safety;
- perform health education tasks;
- participate in rehabilitation;
- provide first aid;
- apply anatomical, physiological, patho-physiological and clinical knowledge during his or her work.
