- perform preventive dental interventions, oral hygiene treatments on outpatients and inpatients based on the indication and under the supervision of the dentist;
- perform the stomato-oncological examination of oral cavities;
- apply provisions and rules on accident prevention during his or her work;
- recognise situations carrying health risks, risks of infection, mode of transmission of infections in time;
- apply the rules for the treatment of patients proven to have been infected and considered as 'high-risk';
- apply options for the prevention of transmission of infections between patients and/or between patients and the personnel;
- provide first aid in accordance with the relevant rules;
- work in accordance with general ethical norms, his or her job description, tasks, rights and obligations;
- get information in foreign-language literature on dental prevention procedures which may be applied by him or her;
- apply basic IT knowledge at user level.
