- perform the tasks due during the introduction of surgical anaesthesia;
- perform the tasks due during the maintenance of surgical anaesthesia;
- assist to the finishing stage of anaesthesia;
- create the conditions right for epidural anaesthesia;
- assist in completing regional anaesthesia;
- participate in escorting and housing the patient to the hospital ward, provide information about the type of anaesthesia used as well as the required nursing and monitoring tasks;
- participate in teaching training assistants as well as in the research and development of anaesthesia.
