- Perform assistant cinematographer (focus puller) tasks, i.e.: prepare, set up, operate recording equipment in accordance with the expectations, and perform their daily maintenance, manage recorded materials and data carriers, assess distance and light, set up acuteness and iris;
- Perform sound recording assistant tasks, i.e.: prepare, set up, operate microphones and sound recording equipment in accordance with the expectations, and perform their daily maintenance, manage recorded sound materials and data carriers, participate in sound recordings (microphone usage, recording correction);
- Perform gaffer tasks, i.e.: install and operate temporary electronic networks, prepare, set up, operate lighting equipment (lamps, filters, foils, diaphragms) in accordance with the expectations, and perform their daily maintenance, prepare, set up, operate camera holding and moving equipment in accordance with the expectations, and perform their daily maintenance, perform other decoration tasks (stage tasks);
- Perform tasks related to recording management, i.e.: prepare plans within his or her scope of duties (such as partial budget, logistics and schedule), prepare specific tasks (negotiation, organisation in the legal area and field of disposition), perform tasks related to actual recordings (check up, organisation, contract conclusion, payment), prepare clearings and reports;
- Perform assistant director tasks, i.e.: clarify the nature, style and instruments of the production, perform plans related to his or her scope of duties (such as lists, disposition book), prepare recordings (disposition, decision-making within his or her competence), keep contact with staff members, contributors and partners, manage and script;
- Perform dubbing assistant tasks, i.e.: cut the material to be dubbed into units, perform the recording copy and indicate the parts to be dubbed by the actors, cooperate in the dubbing and its supervision;
- Perform assistant editing tasks, i.e.: script recorded materials for the preparation of editing, synchronise separately recorded video and sound materials, prepare materials for sound and laboratory post-production.
