## 3. PROFILE OF SKILLS AND COMPETENCES

A typical holder of the certificate is able to:

- cooperate with line managers, experts, employees, outside experts, maintenance staff to minimise risks associated with the tasks performed with lifting machinery;
- cooperate in implementing the health and safety tasks of the operating employer;
- provide for the commissioning of the lifting machinery, and the putting into use, the proper use, preservation of safe condition, periodic inspection and regular and professional maintenance, the load suspension equipment;
- register and keep all documents of the lifting machine and the load-suspension device until disposal of the lifting machine or the load-suspension device, especially the following documents: results, documentation of regular inspections, = required receipts, certificates, lifting machine logs, technician's declaration related to maintenance works and replacement of the main part, rope, hook and chains;
- arrange for the suspension of lifting machine operations for periodic inspections and repairs;
- update the operating documentation and records of the lifting machinery and the load suspension equipment and keep those until the lifting machinery is scrapped;
- ensure that the user manual of the lifting machine which complies with the Machinery Directive be available for the operator until disposal of the lifting machine, and ensure that the description of the normal use of the lifting machine be available for the lifting machine operator;
- ensure normal use of the lifting machine and the load-suspension device and its required storage when it is out of use;
- schedule and check regular inspections of the lifting machines, the load mounting, and check the results of regular inspections and in their knowledge, organise necessary repairs, ensure suspension of the operation of the lifting machine, if necessary. Organise suspension of the operation of the lifting machine for the regular inspections and repairs;
- ensure that the operator is a person qualified as required by law and that the supervisor of hoisting operations and the binder acquire the skills necessary to perform their duties;
- record in writing or arrange for the recording of the operating experience and operational safety relevant to the lifting machinery in the lifting machinery log and organise for the storage of such notes;
- perform/have others perform the periodic inspections required by law and prepare a test report or evaluate the test reports prepared by others;
- submit implementation proposals to the operator designed to eliminate the defects found in the reports on the periodic inspections;
- prepare proposals and draft contracts for the purpose to solve the tasks related to the lifting machinery referred to his/her competence;
- convey the health preservation value system of the workplace to employers and employees.
