- perform hair colouring procedures (hair decolouring, colouring, dying, highlighting);
- perform permanent waving, volume increasing, straightening;
- perform shaving on the face, forming of the beard and moustache, colouring and dying;
- give advice on hair care and professional hairdresser products;
- prepare and inspect the condition before use of the tools of the trade and then clean and disinfect them after use;
- perform a condition check before provision of the services;
- make sure to work only on healthy faces and scalps;
- ensure not to cause any consequences which may endanger or damage the health during the services performed;
- choose the type of service, or recommend to consult a doctor in case of a lesion differing from the healthy state.
