- Backyard raising of main vegetable and fruit species and grapes;
- Apply environment friendly production technologies;
- Perform the work, fire and environment protection tasks related to agricultural production;
- Perform the planning and organisation of agricultural production;
- Apply for agricultural aids, carry out the proper administration of the production;
- Control and supervise the persons and groups performing the production tasks.
