- perform the necessary settings of the circuit specificities based on measurement;
- Delineate the faulty circuit unit or element according to instructions;
- Replace the delineated faulty module or circuit element;
- Prepare minutes about the measurement results and the repair work;
- Provide quality control and mid-production information;
- Based on the technical descriptions operate computerised devices;
- Write and operate simple control programs.
