### 3. PROFILE OF SKILLS AND COMPETENCES

#### A typical holder of the certificate is able to:

- carry out surface testing and stripping indoors and outdoors;
- analyze the structure of the existing layers of paint indoors and outdoors, put the results into writing;
- documented in a note;
- make professional recommendations regarding the classification of the surface to be refurbished;
- calculate material needs based on the design or on site;
- carry out preliminary treatment of the surface based on the test results;
- prepare the site for the work with the necessary machinery, tools and equipment;
- protect surfaces not to be painted (cover or mask them);
- repair render surface indoors and outdoors;
- repair reveals of corners, doors and windows, repair corners (using corner trim);
- spread various fillers on the surface both indoors and outdoors;
- repair properly the joints of building blocks and paving units;
- reinforce substrate using a reinforcing band;
- carry out preliminary works of wallpapering;
- apply backing paper;
- mix and prepare wallpaper paste, do some test pasting;
- cut wallpaper to size;
- paste and hang wallpaper;
- smooth wallpaper;
- refine surface using manual and machine sanding;
- apply primer (impregnation) appropriate to the selected technique;
- mix paint to the right shade and consistency, do test painting;
- apply intermediate layer;
- carry out fine repair as needed;
- apply topcoat using different materials, decorate, indoors and outdoors;
- apply whitewash on new or old surfaces indoors and outdoors in white or other colours;
- plan façade colours, apply them using thin plaster and silicate paint;
- carry out splatter painting and coarse splatter painting;
- paint dividing and decorating lines and paint using stencils;
- paint walls with pattern paint rollers;
- apply simple decorative elements indoors and outdoors;
- use simple wood grain painting technique;
- comply with regulations on safety at work, safety technology, fire safety and environmental protection;
- perform necessary follow-up works (cleaning of tools and equipment, tidying up, storage of materials, waste treatment);
- hand over work area.
