## 3. PROFILE OF SKILLS AND COMPETENCES

**A typical holder of the certificate is able to:**

- make plaster and artificial stone ornamental elements, artificial facing stones, artificial stone tombs, artificial stone monuments, plaster and cement binders, plaster renders and plasterboard surfaces;
- install pre-fabricated decorative elements using different installation techniques, participate in the restoration of monuments;
- produce and pre-fabricate decorative plaster elements, artificial stone elements and structures in accordance with the production technology, in compliance with the technical specifications, on site or at the workshop;
- select and use the necessary hand and machine tools, auxiliary materials and protective equipment for the operations required in the work process, and carry out the maintenance of these tools as necessary;
- make models and moulds for pre-fabricated products from wood, artificial stone, plaster, silicone and synthetic resin;
- shape the surface based on the design plan;
- get to know the installation and labour safety requirements to comply with at the pre-fabrication workshop;
- identify the properties of materials used in the trade, know how to use and store them and have knowledge of the relevant labour and sanitary requirements;
- produce and use target tools such as models, floating rules, squeegees, modelling tools and rings;
- make simple basic structures using meshing, plasterboarding and plastering techniques;
- make simple and complex plaster ornaments with pre-fabrication or on site;
- weld, repair, restore edges and corners;
- install pre-fabricated plaster and artificial stone elements;
- make moulds of various materials and structures required for pre-fabrication;
- pre-fabricate cast stone moulds;
- install and fit pre-fabricated artificial stone elements;
- work artificial stone elements using manual and mechanic tools;
- restore artificial stone elements by manual and mechanic means;
- make, restore and assemble tombs on site;
- make simple plaster and clay moulds;
- make and restore simple artificial marble at the workshop or on site;
- restore and professionally disassemble old, outdated plaster and artificial stone structures;
- perform and repair on-site plaster ornaments, check the working conditions, take measurements on site;
- understand the content of available technical documentation and use basic architectural concepts;
- apply and understand technical drawing methods, read construction drawings;
- use the notation of different structures, understand the spatial positioning of structures, comprehend the content of different levels of documentation and use them in practice.
