- The customs administrator's knowledge makes the employee suitable for the performance of customs tasks arising in connection with the European Union (EU) and third countries, on the basis of the classification of goods according to the Commercial Customs Tariff, as well as the obligations defined in EU and domestic customs legislation related to customs administration procedures.;
- in possession of the competence, the customs administrator handles the electronic customs systems in accordance with the legislation during their licensing and customs clearance activities, fulfills their obligation to preserve records and documents;
- during the performance of their tasks, on the domestic level, they keep in contact with the customs bodies of the National Tax and Customs Administration (NAV), trade licensing authorities and authorities that monitor compliance with product safety regulations;
- cooperates in the execution of customs inspections, fulfils commercial statistical data reporting obligations;
- an individual with a qualification as a customs administrator is capable of using the EU's integrated electronic trade customs tariff system (TARIC) on a regular and routine basis;
- furthermore, they are capable of using the company's customs software on a regular and routine basis, is familiar with the system of customs, customs-related trade policy measures and tariff concessions as well as the related rules on the origin of goods;
- performs the calculations necessary for the fulfilment of tax obligations related to import or export traffic, as well as the application of customs and tax securities during customs clearance procedures with their knowledge and the application of customs value rules;
- participates in the performance of customs licensing tasks, uses the various EU licensing IT systems and the interfaces required for electronic administration;
- is familiar with and uses documents related to the transport of goods and the rules of INCOTERMS 2020;
- collects and records the data necessary for the performance of customs tasks, is capable of selecting the optimal customs procedures for production and trade transactions and apply them in accordance with the legislation.

### WRITTEN EXAMINATION EXERCISES

Examination part A): Goods classification knowledge. The tasks of the written examination are to be completed by candidates with the use of the online TARIC WEB system (http://kkk.nav.gov.hu/eles/1/taricweb/). Candidates perform the tariff classification of goods, in the case of products that can be classified with the use of the Combined Nomenclature, by applying the rules of the classification of goods, and answer theoretical questions related to the classification of goods. Examination part B): Customs law knowledge. This part of the examination tests the following learning outcomes: knowledge of the

Examination part B): Customs law knowledge. This part of the examination tests the following learning outcomes: knowledge of the Mandatory Tariff Information (KTF) system, its data protection regulations and the rules regarding jurisdiction and deadlines related to the issuance of the KTF. The knowledge of the EU KTF inquiry module and the e-BTI system. Knowledge of the KTF issuing process. Topics: basic rules of customs administration procedure and its European and national legal background; rules of customs value and origin; application of trade policy measures; method and procedure for determining customs duty/customs bond; the basic rules of the legal remedy and sanction system.

#### PROJECT EXERCISES

The candidate can start the project task after successfully completing the written exam activity. The 50 customs law case examples of the professional customs associations are available on the website of the Ministry responsible for the sector. The candidate is to prepare an A/4-sized examination paper of no less than 12,000 and no more than 20,000 characters on the case example chosen from the above-mentioned list. The examination paper consists of an analysis of the customs law issue presented in the case example, including a presentation of the essence of the customs law provisions concerned by the case example, as well as the consequences that can be drawn from the examination. The candidate will submit their examination paper to the Examination Centre 15 working days prior to the examination. The candidate presents the content of the examination paper to the examination committee 8 working days prior to the examination developed with the use of presentation software, and then conducts a professional discussion with the members of the examination committee related to the presentation.
