**3. PROFILE OF SKILLS AND COMPETENCES**

- assesses and records the identification data of the received stone (colour, size, shape, weight, light, transparency, condition);
- recognises the signs of the most important treatments (painting, heat treatment, irradiation etc.);
- is able to distinguish different synthetic stones, artificial products, imitations from precious stones;
- identifies the various crystal forms on crude, idiomorph crystals for their classification, carries out mineralogical analyses, uses special instrumental methods and tools;
- evaluates test results on a scientific basis and in a consistent manner, and draws up a test report and an expert opinion;
- uses methods, tools and tables in accordance with the international practice for the identification and classification of gemstones;
- makes proposals regarding the design of the cut of the coloured gemstone;
- is able to professionally name and describe the characteristics and condition of the gemstone offered for sale in order to fill in the vouchers and prepare the auction catalogue, and to communicate with the seller, consignor and buyer in an authentic way;
- identifies gemstones independently, estimates their value and sets prices in various commercial, insurance and expert transactions;
- classifies and categorises diamonds on the basis of the 4Cs (colour, clarity, cut, carat weight), classifies and categorises coloured gemstones and cultured pearls to determine their valuation;
- applies in practice the legislation and special procedures relating to the opening and operation of commercial units in his/her area of expertise;
- applies the legislation relating to art conservation and the procedures concerning the management of artworks, and deals with the purchase, sale and expertise of gemstones based on the legal requirements;
- pays special attention to the accident, work and fire safety regulations of the commercial unit/ pawnshop, and to the protection of goods and property.
