- has the ability to set up and operate sound recording equipment, as well as operate sound editing software and archive digital sound files at a basic level:
- is able to design and set up the lighting for a production, install and operate the lights and the equipment used to serve them independently;
- in the event of a failure of the technical equipment used for his/her work, ensures that it is repaired and replaced immediately;
- is able to prepare the budget, logistics and production plan (synopsis, script, technical script) for a production;
- is able to carry out contracting tasks related to shootings;
- is able to carry out the data processing of recorded images, ingest them into NLE system and perform pre-cut scripting;
- is able to set up an 8-input digital video mixer, use its basic functions, and synchronise separately recorded video and audio material;
- is able to prepare and operate open access and dedicated web streaming;
- establishes the appropriate optical, SDI and Ethernet networks;
- liaises with crew members, contributors, directs them as instructed, is able to script the production's recording processes.
