- conducts plant protection based on environmental and professional criteria, and manages plant production activities;
- manages persons and departments performing plant production tasks;
- sets up, controls, maintains, and operates the machines, equipment, and installations used in plant production;
- follows the rules on work, fire, accident, and environmental protection, as well as the requirements of the Agricultural Safety Policy.
