- possesses the general knowledge of animal husbandry, the physical and practical skills required to carry out farm work, with the ability to work under supervision;
- cares for and feeds farm animals (cattle, sheep, goats, pigs, poultry) in accordance with animal hygiene, animal welfare, health, safety, fire and environmental protection requirements;
- cares for the animals, carries out animal husbandry tasks, forages animals (feeding, watering), operates livestock machinery, maintains machinery, buildings and structures, carries out simple repairs, complies with environmental, fire and occupational safety regulations;
- takes part, under professional supervision, in the performance of tasks relating to the keeping, breeding and trade of farm animals, and carries out simple or seasonal agricultural tasks relating to the keeping, breeding and trade of farm animals as assigned to him/her;
- cares for the safe housing of farm animals;
- recognises the oestrus of farm animals, contributes to their mating;
- recognises, isolates, and cares for sick animals, provides first aid;
- completes, signs, and summarises the attendance sheets and the work log;
- prepares feed, forages the animals daily, individually or in groups, carries out organoleptic tests.
