3. PROFILE OF SKILLS AND COMPETENCES

- complies with, explains and enforces all equine accident prevention rules with participants of the horseback tour;
- establishing the stabling for the horses at home, the resting place and at foreign accommodation sites according to the needs of the horses;
- capable of distinguishing between a healthy and a sick horse, gives first aid and conveys the clinical parameters to the veterinarian;
- monitors the documents of self-owned horses and keeps them in order;
- crosschecks, identifies and analyzes the vaccination information and the results of the mandatory blood tests of foreign horses arriving for the tour with their horse passport;
- familiar with the rules, methods, mistakes and importance of how to approach, tie up, groom and harness a horse, and has equine ethology knowledge;
- observes and is able of enforcing with the riders the rules for guiding horses in an out, mounting and dismounting horses, and the rules for starting and ending work with a horse in the stables and in cross-country horseback riding;
- skilled at safely lunging a horse, in compliance with the rules, both with and without a rider, in accordance with the horse's training plan;
- capable of compiling and carrying out the preparation of horses and riders for horseback riding tours while providing for the continuous advancement of the condition of the horses and their level of training.
