**3. PROFILE OF SKILLS AND COMPETENCES**

- the armed security guard carries out guard, patrol and standby on-call duties in premises designated for guarding, public areas or private areas open to public traffic, as required by the relevant legislation;
- checks the entry and exit of persons and consignments to and from the premises, checks the clothing, luggage and vehicles of persons applying for entry, handles security technology systems and communications equipment;
- captures a person caught in the act of committing an offence or infringement and hands him or her over to the police;
- performs transport and personnel guarding and escorting duties on the basis of specific instructions;
- may, in justified cases, use coercive measures in the course of action, as provided by law;
- performs rescue, evacuation, first aid and site security tasks at the scene of a crime or disaster;
- analyses and evaluates the information he or she learns, and reports and writes reports on them;
- hands over and takes over the service in a way and form typical for hierarchical organisations and as specified in the Armed Security Guard Service Regulations, and keeps track of service documents;
- consciously develops his or her physical fitness to perform duties effectively and efficiently;
- cooperates with the designated authorities and the representatives of the obligant, as determined in legislation and workplace regulations;
- carries out enhanced duty tasks (preventive, enhanced and complete readiness) or acts under the authority of the police or the military during a classified period;
- in the course of action, he or she applies the psychological methods and methodological recommendations relating to the situation in question;
- communicates effectively, both orally and in writing, and deals effectively with conflict situations.
