- consult with the client or employer;
- schedule and coordinate the different tasks, consult with partners;
- plan and supervise the drying process of raw materials;
- apply different methods of glazing processes;
- professionally load and operate the kiln, apply the tools used during firing of porcelain and ceramics;
- ensure the smooth operation of ceramics preparation and production;
- monitor the consumption of materials and energy;
- use hand and machine tools and equipment in accordance with technological, health and environmental standards;
- comply with consumer protection requirements when marketing ceramic porcelain objects, guarantee the quality of the ceramic/porcelain objects ordered;
- design the image of the company or product, create a corporate image or brand manual;
- design the graphic elements of advertising campaigns;
- create infographic and data visualisation graphic content;
- develop visual concepts;
- make the graphic design of webpages;
- create designs according to the technical requirements of the end-use, carry out appropriate pre-press work relying on their knowledge of printing processes and finishing work;
- choose the right type of paper for the work relying on their knowledge of paper types;

A) Art history topics: ancient Egypt, ancient Greek culture and art, ancient Rome, early Christian and Byzantine art, Romanesque, Gothic, Renaissance art in Northern and Southern Europe, European Baroque art, German Lowland and Spanish Baroque painting, Classicism and Romanticism, historicist stylistic trends in the 19th century, and the 19th century. Realism, Impressionism and Post-Impressionism, Art Nouveau and Symbolism, art movements of the first half of the 20th century, architecture in the 20th century, post-World War II art trends in Europe and the United States, major Hungarian artists and works of the 20th century B) Ceramics theory topics: History of ceramics (ceramics of prehistory and ancient civilisations, the development of European ceramic centres from the Middle Ages to the 20th century, 20th century ceramic/porcelain, ceramic culture of the Far and Middle East, ceramics of Pre-Columbian cultures); Professional knowledge (clay formation, raw materials, physical and chemical properties of ceramics, classification of ceramic porcelain products, raw material preparation from handicraft techniques to factory techniques, role, types and raw materials of glazes, ceramic porcelain colours, glaze preparation and glaze defects, drying and firing of ceramic porcelain products, kiln types and thermometry)
