3. PROFILE OF SKILLS AND COMPETENCES

- the hairdresser is a chemical specialist, who washes and conditions the hair in the hairdressing salon using products suitable to the type and condition of the hair;
- select both colour-changing and shape-changing products in a well-communicated way, taking into account the client's wishes and personality;
- the hairdresser is a chemical specialist who uses colour-changing products, techniques (colouring, bleaching, highlighting) and hair colouring tools professionally;
- consciously apply shape-changing techniques (permanent waving, permanent straightening) and products;
- recognise individual personality types and make recommendations for the selection of hair colour and colouring accordingly;
- apply hair dyes and colourants consciously, taking into account the desired purpose, the client's wishes and the quality of the hair;
- selects the right strength of oxidation and hair-conditioning products, taking into account the wishes of the client and the quality of the hair, in a conscious and safe manner;
- select and consciously apply the appropriate tools, materials and procedures for the shaping of the cold holding wave to achieve the desired result, taking into account the client's wishes, hair type and quality;
- select and apply permanent hair straightening materials and application periods according to the type and condition of the hair;
- provide advice to the client on home hair care and styling after each session.

- A) Hair colour changing, written solution of a specific task, detailing the whole process of the colour changing (client's request, basic colour, diagnosis, defining technologies, product selection, use, mixing ratios, application period, advice); detailed description of the complex treatment with price calculation
- B) Permanent shaping, written solution of a specific task (client's request, permanent wave or permanent straightening), with providing the full, detailed description (diagnosis, technology, products, setting application periods, advice, price calculation) of the task or treatment
- C) Colour-theory – test
- D) Hair texture – test
- E) Identification of personality types – test

PROJECT EXERCISES

- A) Preparing a cold holding wave on a doll's hair using a chemical. Documentation of the method and procedure of the task
- B) First bleaching and shading a model's or a doll's hair. Documentation of the method and procedure of the task
- C) Title of the test: male hair highlighting
- D) Female hair highlighting based on a photograph
- E) Hair straightening of a doll's hair with chemical
