- meet deadlines in accordance with the client's abilities and needs;
- at the time of booking, carry out a professional needs and condition assessment, determine skin type, analyse, advise and arrange appointments;
- draw professionally in both analogue and digital environments;
- size, position and prepare the sample;
- create an outline sketch of the envisioned pattern;
- prepare themselves, the tools and the work space (skin) consciously, isolate the surfaces;
- use personal protective equipment, apply the pattern;
- use materials and electrical equipment in a professional manner when creating body tattoos;
- contour, fill and shade with confidence using a tattoo machine;
- be proficient in various application techniques: water shading, grey monochrome, colour;
- follow rules and pay great attention to hygiene regulations;
- after completion of the tattoo, give practical advice on follow-up care, clean up, handle waste;
- prepare a portfolio to monitor his/her own progress and perform marketing activities;
- apply traditional and new professional practices, considering them to be of decisive value.

Part A: Presentation of examination work, portfolio and professional discussion

Topics of the professional discussion: organisational tasks (arranging appointments, management of tools and patterns), knowledge of materials and tools for body tattooists, history, present and future of body tattooing (traditional and new professional tools, materials, methods), pattern design (professional editing guidelines: anatomy, segmental indentation of the human body, natural directions of tension of human skin, currents of the human body; composition guidelines; colour theory), freehand drawing and contemplative vision, stencil application, application techniques (water shading, grey monochrome, colour technique), conditions for body tattooing (set by the tattoo artist and the guest), body tattooing style (characteristics, stylistic features), tattooing follow-up care, infection control, infection control protocol, tattoo machines (parts, features, set-up, preparation, maintenance, troubleshooting), tattoo needles, needle groups (size, quantity, tip, type), needle vs. beak grips, waste management, portfolio and marketing

Part B: On-site completion of the examination work and presentation of the work plan prepared previously

The examination includes contouring, filling, typesetting and all procedures must be carried out on site

The work plan includes: a description of the client's condition and needs, a description of the professional working guidelines used to prepare the design, a detailed explanation of the choice of materials and tools (drawing tools, needle characters), an explanation of the choice of the finishing technique, a description of the layering and the order of the finishing
