3. PROFILE OF SKILLS AND COMPETENCES

- personal and property security guards perform duties in private residences, state, diplomatic, municipal, trade-logistics facilities, public spaces or private areas open to public traffic in the framework of guard and patrol duties prepared by the client pursuant to the Act on Property Protection and on the basis of service or guard instructions prepared for the specific conditions of the given duty station;
- oversees the entry and exit of persons and deliveries into the area of the facilities, checks and manages access control, inspection, protection and signaling systems. Performs patrol service in public spaces, carries out security and site inspections in the premises of shops and sales areas, serves as a member of an emergency response service;
- takes part in providing security for sports, cultural, political and other mass events;
- monitors entry and exit to the event venue, including verifying the legality of entry, detects the entry of materials, devices, prohibited symbols, pyrotechnic materials that are particularly dangerous to public safety and prohibited by the organiser;
- removes persons hindering or disturbing the event, carries out and/or participates in evacuation measures when necessary;
- provides for the safekeeping and protection of banks and financial institutions based on assignments;
- arrests and detains persons caught in the act of a crime or violation of the law at their place of duty, and hands him over to the competent authority. In the course of their actions, in a situation of legitimate defence or necessity, they may use coercive physical force or personal safety device available to them to repel the attack in line with professional regulations;
- performs the transport of money and valuables within and outside the premises of facilities, takes part in the implementation of consignment escort tasks;
- secures locations and performs parking attendant duties as an assignment;
- assists in extraordinary events, takes part in responding to public menaces upon request, takes defensive measures against the criminal use of explosives and explosive devices;
- analyzes and evaluates information that they have been provided, which they record in a predetermined manner and files reports on them;
- transfers and takes over duties in the specified manner and form, and keeps service documents in order;
- provides first aid, resuscitation and, when necessary, conducts conflict and/or stress management to this end, they apply the acquired psychological methods relevant to the situation;
- cooperate, as appropriate, with the designated authorities and the client's representatives.
